

# Privacy Policy

“Trade Greenline ” is a product and database name of **S.N.A. GLOCALS TRADING LTD.** Trade Greenline’ web sites and its services, Trade Greenline databases, datas and products are collectively referred to as “Trade Greenline Services” in this Privacy Policy and Trade Greenline Terms and Conditions.

This Privacy Policy applies to Trade Greenline Services by Trade Greenline.

This Privacy Statement applies to information, including company and personal information, collected about you by Trade Greenline. By using this web site, you agree to the collection and use of information available on or through this site (including your personally identifying information) by Trade Greenline.

Trade Greenline web sites is an e-commerce web site that companies market their products and services in the digital platform. Disclosure of company contact and product information which companies fill in during registration in Trade Greenline will not be shared with any 3rd Party without a written consent of the users. Validity and accuracy of information available on or through this site (including your personally identifying information) is not guaranteed by Trade Greenline. All information are given and filled by the companies.

Trade Greenline web sites may include hyperlinks or links to other web sites or resources. Trade Greenline are not responsible for the privacy policies of those sites. Trade Greenline recommend You or the User review the privacy policies of each site you visit.

Trade Greenline only processes personal information for the purposes described in this Privacy Policy.

## The Information We Collect

Trade Greenline provide a number of services that do not require you to register to Trade Greenline or provide any personal information to us. In order to provide all Trade Greenline Services, we may collect the following types of information:

- **Information You Provide** – When you sign up to Trade Greenline, we ask you for personal information (like your name, company name, email address, your product technical specifications etc). For certain services, such as our advertising programs, we also request credit card or other payment account information. We may combine the information you submit under your account with information from other Trade Greenline services or third parties in order to provide you with a better experience and to improve the quality of our services. For certain services, we may give you the opportunity to opt out of combining such information.

- **User Communications** – When you send email or other communications to Trade Greenline, we may retain those communications in order to process your inquiries, respond to your requests and improve our services.
- **Affiliated Trade Greenline Services On Other Sites** – We offer some of our services on or through other web sites. Personal information that you provide to those sites may be sent to Trade Greenline in order to deliver the service. We process such information under this Privacy Policy. The affiliated sites through which our services are offered may have different privacy practices and we encourage you to read their privacy policies.
- **Other Sites** – This Privacy Policy applies to only Trade Greenline Services. We do not exercise control over the sites displayed as search results in Trade Greenline Databases and web sites or links from within our various services. These other sites may place their own cookies or other files on your computer, collect data or solicit personal information from you.

## **Cookies**

Trade Greenline may store some information (commonly known as a "cookie") on the User's computer when the User visit Trade Greenline web sites. Trade Greenline are able to read these cookies for information purposes when you revisit Trade Greenline web sites. The type of information Trade Greenline collect as a result of a cookie being accepted by the User is specific to the User PC and includes the IP address, the date and time the PC visited the web site, what parts of Trade Greenline web sites were visited at and whether the web pages requested were delivered successfully.

Trade Greenline use the cookie information to improve its knowledge of the use of Trade Greenline web sites and to enable Trade Greenline to be able to ascertain whether its web sites is operating at an optimal level. This allows Trade Greenline to enhance its web offerings to the User and to provide an innovative online experience.

We use cookies to improve the quality of our service, including for storing user preferences, improving search results and ad selection, and tracking user trends, such as how people search and use Trade Greenline Services.

The User can erase or block this information by changing the settings on his or her computer. If the User do erase or block this information User may not be able to utilise some features of the Trade Greenline web sites.

## **Web Beacons**

Trade Greenline or third parties with whom we have contracted or sub contracted, may use web beacons on our web site, in our emails, in our advertisements on other web sites, or in our advertisements in others' emails.

A web beacon is an electronic image that can be used to recognize a cookie on your computer when you view a web page or email. Web beacons help us measure the effectiveness of our web site and our advertising in various ways. For example, web beacons may count the number of individuals who visit our web site from a particular advertisement or who make a purchase from our web site after viewing a particular advertisement or they may tell us when a web page is viewed and provide a description of the page where the web beacon is placed. Web beacons may also measure the effectiveness of our email campaigns, by counting the number of individuals who open or act upon an email message, determining when an email message is opened, and determining how many times an email message is forwarded.

The information we collect through web beacons may include some limited personal information, and web beacons allow us to recognize users by accessing Trade Greenline cookies. We may also combine the information that we collect through web beacons with other personal information we have collected from you. We use all of this information to better tailor our marketing to you and may use this information for other purposes, such as to enable a shopping cart, customize content on our web site and undertake internal research.

You can disable the ability of Web beacons to capture information in this manner by declining cookies as described above.

### **Other Technologies**

Examples of other technologies we may use to provide better service to you follow:

- **Web Session Variables.** Information that is passed from one web URL to another as you browse.
- **Browser plug-ins/add-ons.** Additional web components that may need to be installed to enable certain web features on our sites. You have the option not to install these components.

### **Third-Party Advertising**

We may allow third parties, including business partners and ad networks, to display advertising on our sites. Some of these companies may place a cookie on your computer to recognize your computer each time they send you an online advertisement. This enables them to understand where you, or others who are using your computer, saw their advertisement and deliver ads that they believe are of interest to you. We do not control these companies' use of cookies.

## **Choices For Personal Information**

When you sign up for a particular service that requires registration, we ask you to provide personal and your company information. If we use this information in a manner different than the purpose for which it was collected, then we will ask for your consent prior to such use.

You can decline to submit personal and your company information to any of our services, in which case Trade Greenline may not be able to provide those services to you.

## **Information Security**

Keeping information about You secure is very important to us. However, no data transmission over the internet can be guaranteed to be totally secure. Whilst We strive to protect your personal information, We cannot ensure or warrant the security of any information which You send to us whilst it is being sent, and You send such information at your own risk.

## **Data Integrity**

Trade Greenline processes personal information only for the purposes for which it was collected and in accordance with this Privacy Policy or any applicable service-specific privacy notice. We review our data collection, storage and processing practices to ensure that we only collect, store and process the personal information needed to provide or improve our services or as otherwise permitted under this Policy. We take reasonable steps to ensure that the personal information we process is accurate, complete, and current, but we depend on our users to update or correct their personal information whenever necessary.
