

TERMS OF USE

Parties

This section includes the general and legal liabilities of Trade Greenline ("Trade Greenline" or " Us" or "We") and Trade Greenline web sites (currently located at www.tradegreenline.com.cy) and you ("the User" or "You") (paid-free).

Trade Greenline subscriptions are valid for one year (365 days) usage.

Carefully read the following **Terms and Conditions and Trade Greenline Privacy Policy** (which together comprise the "Agreement" and govern the use by you ("the User" or "You") of the Trade Greenline web sites currently located at (www.tradegreenline.com.cy) before using the Trade Greenline web sites. If you do not accept this Terms and Conditions please do not use Trade Greenline web sites for any reason.

This Agreement is entered into between you ("the User" or "You") as the user of the Trade Greenline web sites, the owner of Trade Greenline web sites (currently **S.N.A. GLOCALS TRADING LTD.** ("Trade Greenline" or " Us" or "We").

Trade Greenline Services

This Agreement covers the following services offered by Trade Greenline Services.

"Trade Greenline " is a product and database name of **S.N.A. GLOCALS TRADING LTD.** Trade Greenline' web sites and its services, Trade Greenline databases, datas and products are collectively referred to as "Trade Greenline Services" in this "Terms and Conditions" and Trade Greenline Privacy Policy. This document explains how the agreement is made up, and sets out the terms of that agreement.

Unless otherwise made a written agreement with Trade Greenline, your agreement with Trade Greenline will always include, at a minimum, the terms and conditions set out in this document.

You understand and agree that Trade Greenline will treat your use of the Trade Greenline Services as acceptance of the terms and conditions set out in this document from that point onwards.

"Trade Greenline Services" is a trade / business information service managed centrally by Trade Greenline and includes the provision of trade / business data and information compiled, processed and organized using a method developed by Trade Greenline, together with other information and related services.

Most of the Trade Greenline Services can only be accessed by registration and are not available to all users. By registering for the restricted areas of the Trade Greenline Services, You agree to the sections of this Agreement that apply to those Trade Greenline Services.

You acknowledge and agree that Trade Greenline permanently or temporarily may stop providing the "Trade Greenline Services" (or any features within the "Trade Greenline Services") to You or to Users generally at Trade Greenline's sole discretion, without prior notice to you. You may stop using the "Trade Greenline

Services” at any time. You do not need to specifically inform Trade Greenline when you stop using the “Trade Greenline Services”.

You acknowledge and agree that if Trade Greenline disables access to your username and password, you may be prevented from accessing the “Trade Greenline Services”, or other content given by Trade Greenline.

Trade Greenline reserves the right to amend, modify or suspend the form and nature of “Trade Greenline Services” (or any part thereof) from time to time. You acknowledge and agree that Trade Greenline can limit the usage of “Trade Greenline Services” at any time, at Trade Greenline’s discretion.

Trade Greenline Services can’t be used as part of any product or service or supplied to any third party in any way by anyone or any organization which competes with the business or products of Trade Greenline.

"the User" or "Your" Liabilities

The risks caused by using the Trade Greenline Services in the Trade Greenline’ web sites are belonged to the users.

You agree to use the “Trade Greenline Services” only for purposes that are permitted by the Terms and Conditions which defined in this agreement and any applicable law, regulation or generally accepted practices or guidelines in the relevant jurisdictions.

In case the software and hardware, that you use, are damaged by any software used in Trade Greenline web sites, we are not responsible for this reason.

The all risks related to the links in Trade Greenline web sites are belonged to the User or You.

Trade Greenline web sites have the right to use all your membership information for their commercial activities.

The User can not use the Trade Greenline Services in illegal purposes.

Fees and Security
